- ❖ Every application for an Annual Practicing authorization shall be accompanied by proof that the applicant has secured at least two Credits (or 30 hours) of CLE during the previous year;
- ❖ This Calendar does not include Courses offered by independent accredited CLE providers;
- ❖ The Council of the Bar may accredit any other course during the course of the year and that course will be communicated to advocates;
- ❖ RBA Members are required to pay 30 days in advance to aid in CLE logistical planning;
- ❖ Registration shall be done on the Rwanda Bar Association Website through the RBA Management Information System/MIS through this website: www.rwandabar.org.rw;
- ❖ All CLE Seminars will run in accordance with the timing in the calendar;
- ❖ Professional Ethics & Discipline shall be provided as subtopic in at least every two day training session;
- ❖ Any RBA member who attends events or training session facilitated by other independent institutions accredited by RBA shall make an individual application for accreditation not later than 20th December;
- ❖ The CLE training or event may take place in any area on the Rwandan territory provided that at least 50 advocates based at that specific area have registered for a given CLE event (ex: Kigali, Musanze, Huye, Kayanza);
- ❖ Any changes to this calendar will be communicated to the membership via email and the RBA Website;
